## **NFYSL STATE OF THE LEAGUE REPORT**

Since being elected as NFYSL Commissioner two years ago, we have made some significant advancement in the following areas:

- We have accumulated revenues (+/--\$10,000) from a projected deficit of \$1200 in 2009. We have accomplished this by finding inexpensive meeting places, collecting fines and late fees, and being frugal with the rest of the yearly expenditures. Further, the league has grown by approximately 10% since 2009.
- We have introduced and fostered the aid of the Director of Coaching positions at all the clubs to help “flight” the teams and to work-out scheduling conflicts.
- We have introduced a new Referee Report form to make discipline issues more streamlined.
- We paid for an updated Scheduling Program which has been replaced by “Got Soccer” scheduling program.
- We have had three (3) Commission Cup Recreational Tournaments which were free (no cost) to the participants.
- We have underwritten and shared the expenses of numerous Coaching Clinics.
- We have donated money to four (4) area-wide T.O.P.S. Soccer programs for handicapped kids.

- We have paid for a motivational speaker to come speak to the NFY Coaches and Players.
- We have produced the NFY Schedule on or ahead of schedule 75% of the time (only once did the schedule come out one week before the 1<sup>st</sup> game).
- We have accommodated schedule changes every season for the past two (2) years.
- We have purchased +/- \$2,500 worth of supplies for the teaching of new referees as well as recertification of existing referees.
- We negotiated with Central Florida League, West Florida teams and other South Georgia teams about combining with NFYSL.

We still have areas to work on:

- Getting clubs to provide the Referees with the correct FYSA Game Reporting forms.
- Working with clubs to lower the incident rate of coach ejections and parental misconduct.
- Continue negotiations with Central Florida teams, Tallahassee and Georgia teams to expand NFY.
- Streamline the scheduling process to eliminate scheduling conflicts, ghost teams that do not form, etc.
- Ensure the communication link from NFY to Club is multifaceted.

This is a mass e-mail for all FSR Administrators. Yesterday May 1, 2011 was the last course offered for registration for 2011.

Please be advised registration for 2011 will be closed Friday, May 6, 2011.

If any students who have not passed the written test by May 6, 2011 they will not be registered for 2011. League GM will close 2011 registration on Friday, May 6, 2011.

The 2012 registration will be open on Monday, May 9, 2011 so administrators will have the capability to start posting courses for 2012 registration.

Please be advised that the earliest entry-level courses can be set up is late July or early August, as we have no idea when US-Soccer will be providing us the books, badges and the entry-level referee test. Last conversation I had was they will be mailing them out after July 5, 2011 and once I receive them I will pass or mail them to the Area Administrators for distribution ia we do every year.

I send all of you last week number of registrations for each area, comparing 2010 to 2011. As you can see the numbers are quite low in comparison to previous years. **I strongly suggest that you contact the local clubs and assignor's in your area and request them to start soliciting for new referees so that we can replace the ones we lost.**
