Hey everyone,

I've been in touch with Mike Levine about funding for JV soccer and a possible donation from the league. I addressed your previous concerns with him. Here is his reply:

Thanks for your reply! At this time, a \$1500 donation added to the funds we have already raised would ensure that JV soccer was reinstated (I just sent out an email to the coaches informing them that we are \$1500 short of our goal). If the soccer is not reinstated, no funds will be turned over to the school district. Future funding is going to be an ongoing concern. There is no guarantee that we will not be in the same situation next year but the powers that be understand they cannot go back to the same groups that helped this year.

The sooner you could get an approval for the donation, the better it would be seeing as the girls teams start practice/tryouts Monday with the boys following a week later.

If NFY is able to make the donation, I am certain we can get some good PR out of the check presentation.

Let me know if there are any other questions I can answer.

Mike, what is our balance at this time?, I understand we haven't collected all the money for our 365 travel teams so I know there is more coming in. We also have approx 4-5 teams that didn't form and we still have to collect from those clubs.

I understand that many clubs are not located in Duval County, but the High Schools in other counties do play soccer against Duval and not having a JV program in Duval will affect the JV programs in other counties.
