Subject: Registration Fee increase for NFYSL

Good Afternoon,

I was made aware at last night's league meeting that it would help the clubs if I provide more information about the increase in league fees. First, after more contact with other leagues in the State about their league fees and Board compensation our increase will now go from \$15 to \$40. The increase will allow us to collect an extra \$10,000 per season, (based on 400 teams) to be used for admin fees, added coaches/referee training, team reimbursement for advancement and possible scholarships for players/young referees. We know with the awarding of more ECNL and DA clubs the number of teams will go down.

To put this in perspective here are team fees for the other major leagues in the State. GCF (Orlando) - \$100, USA League (Tampa) 9/10U \$200, 11U and Up \$275, SFUYSA (Miami) \$125, CDL (Miami) 11U-14U - \$360, 15U and up \$260. Most of these leagues compensate their boards.

Eight years ago NFYSL increased fees from \$10 to \$15. We need to start getting in line with the rest of the market and treat the NFYSL board members the same as the other leagues, while continuing to provide the coaching and referee training we have in the past and still be able to compensate the teams that advance to Regional play from State/Presidents Cup. In the past 4 years we've spent \$9000 on coaching clinics which were open to ALL clubs. We provided \$7000 last year alone to teams that advanced from Presidents/State Cup. At present rates we bring in approx. \$6000 per season (based on 400 teams). We need to build up our account and to look ahead to provide training opportunities, and that costs money.

This season we have scheduled 1822 matches for 400 teams.

Presently I am looking at a budget of approx \$3400 per season for administration fees for the league. The new fees would take effect with the FALL 2017 Season.

Scheduleing: \$1 per match, Treasurer/Secretary: \$100 per month of league play, Director of Discipline: \$10 per infraction/appeal, Commissioner: 15% of total registration fees (includes website maintenance)

Obviously the numbers are going to vary based on the amount of teams and games scheduled.








For comparison here is the board compensation from another league

League: Scheduler \$5 per match, approx 2800 matches, Treasurer \$300 PER MONTH, Director of Discipline \$10 per infraction/appeal,

Some teams are paying \$250 for 3 games in the Seminole Soccer League, or paying \$1000 for 3 games in State Cup if you get eliminated in the First Round. Asking for \$40 for 10 games for 14U and below and 6 games at 15U and up is a **VERY** minimal expense based on the rest of the market. The increase will be about 3 dollars per player per season.
