Old Business:

NFY Commissioner asked how Clubs process red card reports. He suggested assignors review reports as player who is a referee is not allowed to referee matches while serving red card. Coaches should notify assignors, DOC and clubs when their players receive a red card and make sure they serve the red card. NFY will now post all red cards on web site. Also Commissioner ask club presidents to monitor their coaches for verbal player abuse and dissent with referees per FYSA Code of Coduct.

Commissioner asked clubs to make sure the appropriate age group field dimensions meet US Youth Soccer rules.

New Business:
